What vital criteria is the constitutional reform in the new Uzbekistan?

- When thinking about this, first of all, it is necessary to highlight three comprehensive development strategies adopted in recent years at the initiative of the President. Because:

firstly, the norms of the Constitution of the Republic of Uzbekistan were further improved within the framework of the "Strategy of Actions on the five priority directions of the development of the Republic of Uzbekistan in 2017-2021"; secondly, a consistent constitutional reform was implemented based on the "Development Strategy of New Uzbekistan for 2022-2026"; thirdly, effective measures are being taken to ensure the direct implementation of the updated Basic Law in the implementation of the "Uzbekistan - 2030" strategy.

Our Constitution is a solid legal source and the main legal guarantee of the wide-ranging democratic reforms that have been carried out consistently and gradually, organically and systematically in all spheres of socio-economic, political-legal and spiritual-cultural life during the years of independence. In any democratic society that strives towards the rule of law, the Constitution takes priority.

In turn, in his speech at the joint session of the chambers of the Oliy Majlis dedicated to the inauguration ceremony of the newly elected President of the Republic of Uzbekistan Shavkat Mirziyoyev on November 6, 2021, he defined the development strategy of New Uzbekistan as the theoretical basis of the constitutional reform. given A separate chapter is devoted to constitutional reform in the President's book "New Development Strategy of Uzbekistan".

It is notable that: a special chapter in President Shavkat Mirziyoyev's book "Development Strategy of New Uzbekistan" published in 2022 is called "Constitutional reforms - an objective necessity on the way to building a new Uzbekistan". It reflects the important proposals and initiatives that were revealed during the pre-election meetings, the conclusions regarding our current progress and future plans.

Therefore, it is of great significance to organize events claiming the essential place and role of our Constitution in national law system to Uzbek people. Apart from that it is very crucial to boost knowledge of students about Basic Law - the Constitution of Republic of Uzbekistan, and widen legal proficiency of them. If relevant professionals give permission, it is also vital to emphasize on our Constitution by the help of public information tools as it is solid foundation and legal guarantee and a shining example of our freedom. In addition, presenting short videos and films proving the acceptance of Constitution became one of the important stages in the development of our country is needed.

Moreover, Basic Law paved a path for providing peace in our society, human rights and freedom, and opportunities to make positive changes in political, economical and social domains. Furthermore, it serves as a legal basis for consecutive trajectory in social relationships. Practical Constitution consists of constitutional right. It is considered that the role of Constitution in any national law system is supreme. Additionally, every single country has its own Constitution, since they consider it to be a strict path which is followed by all members of any single society.

Our Constitution not only ensured with safe and prosperous life, but also it gave a mountain of opportunities for young generation in all spheres ranging from science, medicine, entrepreneurship, economy, finance and others.
