GUARANTEE OF HUMAN RIGHTS IN THE CONSTITUTION OF THE REPUBLIC OF UZBEKISTAN

Abstract. The international community has strengthened the main democratic principles and requirements in the field of ensuring human rights and freedoms, and the Universal Declaration of Human Rights, which served as a political and legal basis for the formation of the entire system of international law related to this field, and the Constitution of the Republic of Uzbekistan are devoted to the guarantee of human rights.

According to the Constitution of the Republic of Uzbekistan, a person, his life, honor, dignity, rights and freedoms are the highest value. Also, the adoption of the Children's Ombudsman Law in 2021, i.e. the International Year for the Elimination of Child Labor, is a clear proof of our opinion that it is a truly historic event.

This can be observed when the UN has become a prestigious international organization, the importance, status and priority of the legal documents adopted by it in the formation of national legal systems are increasing. In his speech, the head of state announced the ratification of the Optional Protocol of the Convention against Torture, and also pointed out that preparations are being made to invite a special rapporteur on torture to Uzbekistan in order to cooperate on these issues.

A person who considers himself a human being, who has even a little love for his country and people in his heart, will not hurt the honor, dignity and reputation of other people, no matter who they are. Hurting someone's tongue, unjustly accusing, insulting, oppressing, oppressing and endangering someone, causing cold relations between two people, avoiding help and support in difficult situations, refusing and cheating, defrauding the house by fraud and theft, in a word in other words, oppressing people, regardless of nationality, religion, is characteristic of people who do not have the virtue of humanity. After all, such vices are strongly condemned in the "Holy Qur'an", and the verse 135 of the "An'am" chapter says: "Undoubtedly, the oppressors will not be saved", which indicates that man is the greatest and dearest creature.
